#### **D.** Basic Competency Requirements

Competency requirements exist for the areas of English (Reading and Writing), and Mathematics. Students must demonstrate competency according to the following in each of the areas in order to be eligible for the A.A. or A.S. degree.

- 2. Mathematics/Quantitative Reasoning: Satisfy one or more of the following requirements
  - a) Satisfactory Completion of **MATH 120 (Intermediate Algebra) or MATH 190** (Path to Statistics) or BUS. 113 (Personal Finance) with a grade of "C" or better, or equivalent; or
  - b) Satisfactory completion of any course having MATH 120 (Intermediate Algebra) or MATH 190 (Path to Statistics) as a prerequisite with a grade of "C" or better; or
  - c) Score of 3, 4, or 5 on College Board Advanced Placement Tests (AP): Calculus AB, or Calculus BC, or Statistics; or
  - d) Score of 4 or higher on International Baccalaureate Exam (IB): Mathematics HL; or
  - e) Placement into transfer-level MATH course using SMCCCD math placement test if taken prior to fall 2019

- e. Placement into transfer-level MATH course using SMCCCD math placement test if taken prior to fall 2019
