Daniel therefore updated SLOs and added additional information to the content outline of the course.

Susan Mahoney presented on behalf of the above item. She shared that the department has been wanting to add a course on climate change for some time, and now that the campus is revising the AS degree, it seemed appropriate to add at this time. Many UCs, CSUs, and community colleges have courses on climate change, and

the department thought it would be wise to add a course for the degree but also to promote environmental literacy and understanding of this important issue for students.

Susan Mahoney presented on behalf of the above items. She shared that the above four courses relate to the degree revision and are added as selectives for the AS Degree. Susan shared that it took over 2 years for the state to develop the transfer model curriculum for the Environmental Science AS-T Degree. Susan in the meantime developed our campus local degree, incorporating aspects that she felt would be included within the AS-T degree ultimately. For years the campus has had two degrees that are very similar, which does not serve our students. Thus, Susan has revised the local AS Degree with our most common local transfer schools in mind: SFSU, Cal State East Bay, and San Jose State. While the AS-T is great, it is very hard science heavy which scares students away from Environmental Sciences. Transfer students do not need this level of science to be successful in environmental careers, which is why she took the approach she did related to our local degree, ensuring more flexibility for students to attend our local target schools.

■ Vice President of Instruction's Report-

Chialin shared the following information with the committee regarding accreditation:

Here are the next steps for College of San Mateo, Cañada College, and Skyline College. Note that all three colleges will be writing to the 2024 Accreditation Standards (the new standards).

- · We need to schedule the ISER Workshops for each of the colleges to take place early in spring 2024.
- Each college's ISER will be due to the Commission on December 15, 2025.
- Each college will have a Peer Review Team that will review the ISER and provide Core Inquiries to the college usually in March of 2026.
- Each college will have a Focused Site Visit in fall 2026.

Additionally, Chialin shared the standards in which Curriculum Committee will be playing a role:

Standard 2: Student Success

In alignment with its mission, the institution delivers high-quality academic and learning support programs that engage and support students through their unique educational journeys. Academic and learning support programs promote equitable student success, and the institution evaluates student learning and achievement data to inform improvements and advance equitable outcomes.

- 2.1. Academic programs at all locations and in all modes of delivery are offered in fields of study consistent with the institution's mission and reflect appropriate breadth, depth, and expected learning outcomes.
- 2.2. The institution, relying on faculty and other appropriate stakeholders, designs and delivers academic programs that reflect relevant discipline and industry standards and support equitable attainment of learning outcomes and achievement of educational goals.
- 2.3. All degree programs include a general education framework to ensure the development of broad knowledge, skills, and competencies related to communication, quantitative reasoning, critical thinking, information literacy, civic responsibility, and the ability to engage with diverse perspectives.
- 2.4. The institution communicates clear, accurate, and accessible information regarding programs, services, and resources that foster success in students' unique educational journeys.

 - Chair's Report-

Lisa Palmer shared that this morning there was an AB928/AB1111 district taskforce meeting discussing the various complexities surrounding these changes. There will more information forthcoming regarding meeting deadlines established by the state.

Additionally, Lisa shared how to complete and upload the COCI template for new and revised programs, which will be due when a program comes up for renewal. COCI is a state database of courses and programs, and locally, the campus has done a great job updating them and following our review schedule, but this information needs to go to the state database. This piece is sometimes not occurring as it should, which is why this process needs to be addressed.

Frank and Lisa shared the location of the template with the committee. Previously, this process was the dean's role. The new process involves faculty completing the form, and attaching the file to CurricUNET, sending it to their dean and Frank. Only deans have access to the COCI database, so they must ultimately be uploading the forms to COCI.

Leonor highlighted the experience in her division, noting that there are steps in between. The dean will need to check on the status of the form as the reviewers may not send the form back, and revisions may need to be made multiple times. In the new process, the dean will have to pull the form, return it to the faculty, await the changes, and then reupload, which is why historically, this has been a dean only responsibility. Lisa agreed that this could be problematic, but suggested that the campus attempt this new pilot process and reassess if need be. Ana suggested having a meeting with all deans to ensure they are following the correct process with the changes that are being raised at this meeting. The group discussed that this could eventually be an embedded component within CurricUNET, and this will be something discussed at District Curriculum Committee.
