C. Organization of the Self-Evaluation Process

West's institutional self-evaluation has been a collaborative, inclusive, and highly organized college-wide effort. This effort began very soon after the 2020 Midterm Report, which was accepted by ACCJC.

Organization of the Self Evaluation

The College's Self-Evaluation Report is organized according to the sections outlined in the ACCJC Manual for Institutional Self Evaluation. Each response includes a section detailing the Evidence of Meeting the Standard followed by an Analysis and Evaluation section. In the Analysis and Evaluation section, any changes arising out of the Self Evaluation are noted at the end of each relevant standard with the symbol Δ . They are also linked to a matrix at the end of the document that provides the timeline and anticipated outcomes for the actionable plan (C1). The related action projects of the **Ouality Focus Essay are noted in the** standards with the symbol \star . (C2)

Process of the Self Evaluation and Roles of Campus Groups

West Los Angles College charges its Accreditation Steering Committee (ASC) to organize and oversee the preparation of reports to the ACCJC (<u>C3</u>). The Committee includes the ALO, the three vice presidents, the Dean of Institutional Effectiveness, the Facilities Director, and representatives of the Academic Senate, Faculty Guild, Teamsters, and Staff Guild. A faculty member and the ALO co-chair the committee. (C4). Using the established process for selecting faculty for such assignments, the College President selected the current faculty chair for accreditation in October 2020 (C5). The ALO is the Vice President of Academic Affairs.

In 2020, an Educational Master Plan Work Group was established. The President selected a faculty co-chair and appointed the Dean of Institutional Effectiveness. Educational planning falls under the "10+1" academic and professional matters of faculty purview, so West Los Angeles College educational master planning has traditionally been initiated and guided by the Academic Senate. Therefore, Educational Planning and Standards Committee (EPSC) members served as the faculty backbone of the committee, since its members include both the Academic Senate president and vice president. Because the student affairs aspects of the educational experience are also essential, the EMP work group consisted of both faculty and administrators. The work group benefitted from the participation and expertise of colleagues in administration. This project has contributed to the work required for the present Self Evaluation.

The College has a robust participatory governance system relying on committees, so shortly after the current Standards were published in July 2014, the ASC reviewed and updated the established matrix that maps standards to committees. ASC review of the Standards revealed that I, II, and some of the

Standards in III aligned closely with the charges of particular committees:

STANDARD III: Resources

Standard IV is leadership and governance. Primary input comes from College faculty leaders, including the chair of the College Council, the chapter chair of the AFT Faculty Guild, and president of the Academic Senate. ASC members attend monthly District Planning and Accreditation (DPAC) meetings. DPAC reviewed drafts of standards with shared college and district responsibility.

Each of the primary committees were asked to identify evidence that the College meets the Standard for each of the Standards associated with it. A website within the College's SharePoint document management system provided storage and access to these evidence files. During the Spring 2021 semester, faculty, staff, and administrators attended a training focused on Standard evaluation and evidence collection and a Standard Co-Chair writing training focused on writing the ISER. To collect evidence, each shared governance committee was provided with an evidence collection worksheet that included the Standards mapped to the committee, sample evidence, and the evaluation criteria for each Standard. Evidence was provided with a written explanation of how the evidence provided supports the Standards. In addition, the Faculty Accreditation Chair created a writing guide with resources provided by ACCJC to support the evaluation process. Drafts of each Standard were reviewed by the College and made available to the public in a folder on the Accreditation Steering Committee SharePoint page. After the

Accreditation Steering Committee approved the ISER, the report was approved by the College Council, Academic Senate, the College President, and the Board of Trustees.
