

# Directions to Skyline College 3300 College Drive, San Bruno, CA 94066

# **Coming from San Francisco International Airport**

Exit San Francisco International Airport and take the ramp to I-380 West. Keep right at the fork to continue toward I-380 West. Keep left at the fork, follow signs for I-380 West/I-280 West/San Bruno and merge onto I-380 West. Once on I-38, take the first exit onto El Camino Real/CA-82 and turn right at the signal at the bottom of the ramp onto northbound El Camino Real/CA-82. Stay in the left lane and turn left at the next signal onto Sneath Lane. Continue up Sneath Lane for approximately 1.5 miles. Turn right at Skyline Boulevard. At the next signal, turn left onto College Drive. Drive through a residential area. The road eventually dead-ends at the campus. \*At the end of the Loop Road, turn right. Follow the road counterclockwise until you reach Parking Lot M. Parking is available in Lot M (first) and then Lot N as M fills. Lot N can be accessed even before you reach Lot M.

## **Coming from the north:**

## From Hwy 101:

Drive south on 101. Take San Bruno Ave. West exit. Head West on San Bruno Ave. to Skyline Blvd. Turn right on Skyline Blvd. to College Drive. Turn left at the signal onto College Drive. Drive through a residential area. The road eventually dead-ends at the campus. Follow the directions from \* above.

#### From I-280:

Drive south on Hwy. 280. Take Westborough Blvd. West exit, turning right (west). Continue west, crossing Skyline Blvd. Westborough Blvd. becomes Sharp Park Road. Turn left at 2<sup>nd</sup> stoplight at North College Dr., which will lead you to the campus. When you reach the campus, turn left onto the campus Loop Road. Proceed through the roundabout and then turn right into Lot M. If full proceed east to Lot N.

# **Coming from the south:**

## From I-280:

Drive north on I-280. Take the Skyline/Pacifica/Highway 35 exit. Continue north through two traffic signals. At the third signal, turn left onto College Drive. Drive through a residential area. The road eventually dead-ends at the campus. Follow directions from \* on previous page.

## **Coming from the East Bay:**

## From I-580 or I-880:

Follow the signs for Highway 92 west - San Mateo Bridge. Cross the bridge, stay toward the left lanes and <u>remain</u> on Highway 92 west toward Half Moon Bay. Continue up the hill through San Mateo and at the crest of the hill get in the right lane to exit at I-280 north toward San Francisco. From I-280 north take the Skyline/Pacifica/Highway 35 exit. Continue north through two traffic signals. At the third signal, turn left onto College Drive. Drive through a residential area. The road eventually dead-ends at the campus. Follow directions from \* on previous page.

# From I-80 (Bay Bridge):

After crossing the Bay Bridge, follow the signs for Highway 101 south toward San Jose. Drive south on Highway 101 toward San Bruno. Take San Bruno Ave. West exit. Head west on San Bruno Ave. to Skyline Blvd. Turn right on Skyline Blvd. to College Drive. Turn left at the signal onto College Drive. Drive through a residential area. The road eventually dead-ends at the campus. Follow directions from \* on previous page.

#### **Directions to Building 6**

From Lots M or N, proceed into campus. Building 6 is the Student/Community Center and is to your right as you view the campus from Lots M or N. Building 6 has a quote above the rear entry from Mahatma Gandhi that reads, "You Must Be The Change You Wish To See In The World." Continue toward Building 6 and enter at the rear entrance. As you enter Building 6, the campus bookstore will be on your left. Continue past the bookstore to the elevator on your left. Take the elevator to the second floor and turn to the right as you exit. Walk down the hallway and turn to your right to access the campus meeting rooms. Meeting rooms 6202 and 6204 will be down the hallway on the left.
