### **OVERVIEW OF THE DISTRICT'S RISK MANAGEMENT / SELF-INSURANCE PROGRAM**

To mitigate risk in a fiscally responsible manner, the District has employed various risk management programs over the years. Such programs have included participating in Joint Powers Agencies (JPA) and the current structure where the District acts as its own independent risk management and claims administrator while procuring primary lines of coverage above self-insured limits.

The primary insurance categories include Property, General Liability, Workers' Compensation, Cyber Liability, and Crime. The current structure provides a certain level of self-insurance for each category with additional excess liability coverage provided by outside insurance providers. The annual cost of primarily lines of coverage has escalated from \$1.0 million in FY 2015/2016 to \$4.0 million in FY 2023/2024. In addition, under the current model, administrative fees have ranged from \$162K - \$224 per year over the last 10 years.

## OVERVIEW OF THE FACILITIES MASTER PLAN AND CALIFORNIA COMMUNITY COLLEGES CHANCELLOR'S OFFICE FIVE-YEAR CAPITAL OUTLAY PLAN

This report provides the Board of Trustees with an overview of the District Facilities Master Plan (FMP) and the California Community Colleges Chancellor's Office (CCCCO) Five-Year Capital Outlay Plan (5YCP). These essential planning tools guide facility development and capital projects for our district, aligning our campuses' infrastructure with the educational needs of students and the community. Both plans play a critical role in securing competitive funding, ensuring long-term sustainability, and maintaining a high-quality learning environment.

### Facilities Master Plan

The Facilities Master Plan (FMP) serves as a strategic roadmap for districtwide facilities, addressing evolving needs over a 10–15-year period. It outlines the vision for campus development, including upgrades to existing structures, the addition of new facilities, and enhancements to support services and infrastructure. Developed with input from students, leadership, faculty, staff, and community members, the FMP aligns with both the colleges' educational master plan and District priorities, as well as broader community needs.

The FMP is updated every five years to reflect changes in educational programs, enrollment, and District goals. It also serves as a foundational tool in the pursuit of external funding, such as the California State 5YCP, by prioritizing projects that address immediate and future needs while enhancing the District's competitiveness in securing capital improvement funds.

### California Community Colleges Chancellor's Office Five-Year Capital Outlay Plan

The CCCCCO 5YCP is a competitive funding mechanism managed by the State Chancellor's Office to support infrastructure and capital projects for California Community Colleges. Aligned with the District FMP, the 5YCP offers an opportunity to secure state funds for prioritized facility needs.

The 5YCP plays an instrumental role in advancing large-scale projects, including the construction of new facilities and major renovations. By leveraging state funding combined with District resources, the 5YCP enables the District to achieve its long-term facility goals in a financially sustainable manner. Moreover, it positions the District to be competitive in future funding cycles, enhancing our capacity to explore additional capital improvement funding opportunities to meet evolving infrastructure needs.

Together, the FMP and 5YCP are essential to achieving the District's infrastructure and capital improvement goals. In alignment with our District's mission and values, these plans provide a framework for strategic development and responsible stewardship of District resources. As we continue to compete for state funding and explore future capital improvement funding opportunities, the Board's support and understanding of these plans are critical to advancing projects that will shape the District's campuses and expand our community impact.

### **CAPITAL PROJECT AND SCHEDULED MAINTENANCE NEEDS**

At its regular meeting on July 27, 2022, the Board of Trustees accepted the 2022 Facilities Master Plan (FMP). Steinberg Hart was commissioned by the District to lead the effort in developing the FMP. The process included site visits, multiple meetings with College and District stakeholders, programmatic departments, students, and community members. The 2022 FMP is intended to be the basis and justification of new construction and / or modernization of capital projects for 10-15 years.

Staff will provide an overview of projects included in the 2022 FMP, both new construction and modernization projects along with anticipated scheduled maintenance needs over the next ten years. In continuing with our current Facilities Master Plan, staff seeks the Board's input and guidance on potential new project initiatives that may align with emerging District needs or strategic goals. Although we are not at a formal review or update interval, we understand the value of staying adaptive to changing priorities, technological advancements, and opportunities that could further enhance our educational environments. Specifically, we seek input and guidance on facilities improvements or new construction ideas that reflect the Board's vision for supporting student success, campus modernization, and sustainability.

Staff recognizes that the utilization of existing facilities is an important factor when considering new capital outlay projects as under utilized facilities can be reconfigured to meet existing needs without constructing new facilities. While the 2022 FMP included an analysis of space utilization, the data was from 2019. Staff seeks Board direction in hiring a consultant to update the District's space utilization analysis to further inform capital improvement needs.

## **CAPITAL IMPROVEMENT PROGRAM (CIP) FUNDING OPTIONS**

At its regular meeting on October 25, 2023, the Board received a comprehensive historical overview of the District's capital improvement initiatives, funded in large part by three General Obligation Bond Measures, including the most recent Measure H passed in 2014. These bonds, along with State matching funds, enabled the District to carry out three major capital improvement programs, significantly modernizing our campuses and creating enhanced spaces for our students and communities to thrive.

With the depletion of Measure H funds, however, the District faces new challenges. Without Measure H as a funding source, our ability to meet the State's match requirement for capital improvement projects is compromised, placing us at a disadvantage in securing State funding for future projects. As such, Staff has recommended a near-term approach of preserving Fund 4 balances in a fiscally prudent manner, which will enable the District to bridge toward upcoming public funding opportunities as they arise.

At its meeting on February 28, 2024, the Board approved following a prudent approach to capital improvements in the near term as the District explores possible public financing opportunities. This approach entails pausing non-essential capital improvement plans and only moving forward with projects that are modest in cost or benefit from generous State funding with a modest match requirement. The Board also approved proceeding with the following projects: CAN CDC, CSM B30, CSM Beach Volleyball, SKY Fields, Student Housing at CSM, Scheduled Maintenance, and ADA Compliance while maintaining a Bridge Fund to support future projects in the amount of \$51.6 million.

Based on the most recent analysis of the Capital Outlay Fund, staff recommends allowing each college to proceed with an additional project up to \$3.0 million each while still maintaining a Bridge Fund of at least \$50 million.

Staff seeks Board guidance on exploring outside financing options to meet Capital Improvement Project needs.
