ADOPTION OF 2024-2025 ACADEMIC CALENDAR

The District Academic Calendar addresses days of work for San Mateo County Community College District employees represented by AFT, CSEA, and AFSCME. The proposed calendar has been negotiated with AFT and provided to CSEA and AFSCME.

The proposed calendar (attached) is designed to begin the 2024-2025 academic year in mid-August with a completion of the Fall 2024 semester prior to the winter holidays. The following highlights the features of the calendar, which is attached in full to this report.

Fall 2024: Classes begin August 14, 2024

87 instructional days (including five (5) days of final examinations and three (3) professional growth flex days)
Semester ends December 16, 2024

Spring 2025: Classes begin January 13, 2025

88 instructional days (including five (5) days of final examinations and three (3) professional growth flex days)
Semester ends May 22, 2025

Summer 2025: All Summer Sessions are set to begin on June 9, 2025

APPROVAL OF CURRICULAR ADDITIONS, DELETIONS AND MODIFICATIONS CAÑADA COLLEGE, COLLEGE OF SAN MATEO, AND SKYLINE COLLEGE

The addition of two courses to, and the deletion of one course from, the College catalogs are proposed by Cañada College, College of San Mateo, and Skyline College at this time. Additionally, five courses are proposed to be offered in the distance education mode.

Fifteen courses and one program were assigned inactive status, which removes them from the catalog and schedule. Since they have not been deleted, they can be more easily reinstated at a later time. If reinstatement is unlikely, these courses and programs will be deleted in the coming years.

Furthermore, 142 courses and five programs were modified.

Each of the proposed courses and programs has been reviewed by the appropriate Division Dean and approved by the College Curriculum or Instruction Committee, acting on behalf of the local Academic Senate. In addition, the Academic Senate Presidents provide oversight with respect to the necessary role of the local Senates in the review and approval process. The rigor of the approval process assures that each new course has substance and integrity in relation to its discipline and that it fills a clear student need not being served by existing course offerings.

The current collective bargaining agreement between the District and Local 829, Council 57, American Federation of State, County and Municipal Employees, AFL-CIO (AFSCME) expires on June 30, 2022. The parties wish to negotiate a successor agreement.

Government Code Section 3547 (from the "Educational Employment Relations Act") provides that:

(a) All initial proposals of exclusive representatives and of public school employers, which relate to matters within the scope of representation, shall be presented at a public meeting of the public school employer and thereafter shall be public records.

(b) Meeting and negotiating shall not take place on any proposal until a reasonable time has elapsed after the submission of the proposal to enable the public to become informed and the public has the opportunity to express itself regarding the proposal at a meeting of the public school employer.

(c) After the public has had the opportunity to express itself, the public school employer shall, at a meeting which is open to the public, adopt its initial proposal.

AFSCME has submitted an initial proposal to the District, which staff transmits with this report to the Board. This is done prior to holding a public hearing on the proposal as required by the Educational Employment Relations Act.

The current collective bargaining agreement between the District and the California School Employees Association, Chapter 33 (CSEA) expires on June 30, 2022. The parties wish to negotiate a successor agreement.

Government Code Section 3547 (from the "Educational Employment Relations Act") provides that:

(a) All initial proposals of exclusive representatives and of public school employers, which relate to matters within the scope of representation, shall be presented at a public meeting of the public school employer and thereafter shall be public records.

(b) Meeting and negotiating shall not take place on any proposal until a reasonable time has elapsed after the submission of the proposal to enable the public to become informed and the public has the opportunity to express itself regarding the proposal at a meeting of the public school employer.

(c) After the public has had the opportunity to express itself, the public school employer shall, at a meeting which is open to the public, adopt its initial proposal.

CSEA has submitted an initial proposal to the District, which staff transmits with this report to the Board. This is done prior to holding a public hearing on the proposal as required by the Educational Employment Relations Act.

APPROVAL OF ASIAN AND PACIFIC ISLANDER AMERICAN (APIA) GRANT FOR COLLEGE OF SAN MATEO

College of San Mateo's (CSM) Mana Learning Community was selected to participate in the Asian & Pacific Islander American (APIA) Scholars Strengthening Institutional Capacity for NHPI Students in Higher Education Program for 2021-2022. As part of this selection, CSM will receive a grant award in the amount of \$10,000. College of San

Mateo will be a part of a group of institutions that represent a wide geographic region, and that serve a diverse NHPI student demography. As a result, CSM Mana will have access to a wide range of specialized resources to expand and further NHPI ontologies in academia and education from other institutions that currently provide specialized support to NHPI students at their campuses. Moreover, this co-investigative research project will bring together professionals and faculty from across the United States (Pacific Nation territories included) to share knowledge and NHPI student climate on campuses. It is with hope that this opportunity opens rich discussion and learning opportunities between institutions.

ACCEPTANCE OF \$480,000 IN GRANT FUNDS FROM THE RISING SCHOLARS NETWORK TO SUPPORT FORMERLY AND CURRENTLY INCARCERATED STUDENTS WITHIN SMCCCD

The California Community Colleges Chancellor's Office (CCCCO) Rising Scholars Network has awarded the San Mateo County Community College District (SMCCCD) \$480,000 (\$160,000 per year for 3 years) to replicate and expand the Project Change model and services across the District's three colleges. Project Change is an award-winning program at College of San Mateo that has served system impacted and formerly and currently detained youth through dual enrollment and on-campus programming. These funds will allow for Skyline College and Cañada College to develop the capacity to provide similar wrap-around services and supports for system impacted youth.

The Educational Services and Planning Division, in partnership with the business office, will be responsible for allocating funds to each of the District's colleges and administering any required maintenance of the Rising Scholars grant, including grant monitoring and reporting.

AUTHORIZATION TO AUGMENT THE CONTRACT FOR SKYLINE COLLEGE BUILDING 1 EXHAUST FANS REPLACEMENT PROJECT

The Skyline College Building 1 Exhaust Fans Replacement Project (Bid Number 86852) removed seven existing and significantly aged rooftop exhaust fans and replaced them with nine new fans. The project was originally within the scope of the primary Skyline Building 1 Update project but was extracted as a stand-alone, informally bid project following California Uniform Public Construction Cost Accounting Act (CUPCCAA) procedures, to accelerate installation to supplement ventilation for COVID-19 response. The Board of Trustees have authorized the Chancellor, or his designee, to award contracts bid pursuant to the CUPCCAA informal bidding procedures (Board Report No. 07-5-101B, Resolution No. 07-4).

On July 22, 2021, a Notice of Award was issued to the lowest responsive, responsible bidder, JKL Construction Services, Inc. for the construction of the SKY B1 Exhaust Fans Replacement project in the amount of \$182,290 which included a 10% owner allowance of \$16,572.

Prior to the removal of the existing fans by crane it was difficult to assess the condition of the electrical infrastructure. The removal of the fans revealed the following deficiencies:

- Existing conduit was broken and wiring seized up rendering it unusable. New conduit runs required new penetrations through the concrete roof as well as roofing repair.
- One fan apparently had been rewired in the distant past, changing voltage, but never recorded resulting in the urgent need to remedy and align with breaker capacities for safety.
- Existing fan controllers, electric supply and shut-off switches were inconveniently distributed in various electric closets. The electrical subcontractor, Bass Electric, wisely recommended the consolidation of controllers and proper location of shut-off switches next to the new fans on the roof.

JKL Construction Services, Inc. has submitted cost proposals for this extra work, which have been deemed by the construction manager & Facilities Staff to be reasonable. Addressing the deficiencies noted above depletes the 10% owner allowance and requires a supplement in the amount of \$19,092.06 to complete the work. The proposed final amount of the contract with JKL Construction Services, Inc. therefore, amounts to \$201,382.06, which exceeds the Chancellor's authority under the CUPCCAA informal bidding procedures. District staff recommends that the Board grant the Chancellor, or his designee, the authority to execute additional change orders to the JKL Construction Services, Inc. contract for this project.

The project will be funded with Measure H general obligation bonds.

The purpose of the Memorandum of Understanding (MOU) is to increase the number of Sequoia Union High School District (SUHSD) graduates who matriculate into postsecondary higher education, and specifically to Cañada College, California State University, East Bay (CSUEB) and San Francisco State University (SFSU). The agreement includes increasing the number of SUHSD students participating in early college access programs (8th grade bridge, dual enrollment Living the Promise Posse Program and Middle College), with intentional focus on increasing participation of students from minoritized communities. The agreement includes the establishment of a joint Equity Leadership Academy for K-14 leaders and business partners and also identifies the need to develop a bridge pathway program between the English as a Second Language, Adult Basic Education, and Adult Secondary Education programs at Sequoia Adult School and the Workforce Development Programs at Cañada College. The development of clear and efficient transfer pathways from Cañada College to CSUEB and SFSU is included as well as the establishment of a data sharing agreement. The MOU shall remain in effect for an initial period of five years and includes periodic reviews, evaluation of activities and an annual joint report on the partnership.

DISCUSSION OF BOARD POLICIES AND DIRECTION ON EMPLOYEE HOUSING PROGRAM

In 2004, the District worked to establish the San Mateo County Colleges Education Housing Corporation, an IRS designated 501(c)(3) organization affiliated with the District for the purposes of managing the District's employee affordable housing program. The Housing Corporation was formed to create an arms-length relationship from the District and to provide independence from the employee-employer relationship and a tenant-landlord relationship.

The Housing Corporation is governed by a board of directors appointed by the District Board of Trustees. The Board of Directors is comprised of two trustees from the District Board of Trustees, a representative recommended by the District Academic Senate, a representative recommended by CSEA and outside professionals with knowledge and expertise in property management, housing, finance, law, etc. The Housing Board meets quarterly and is responsible for the general management and oversight of the District's employee housing assets and sets policies relating to rents, occupancy, eligibility, and the general use and maintenance of the assets, and provides for the general operation of the employee housing program.

The District's employee housing program assets currently include:

- **College Vista**, located on the College of San Mateo campus, is a two and three-story complex with 44 units. This complex opened in 2005.
- **Cañada Vista**, located at Cañada College, consists of two three-story residential buildings with 60 units. This complex opened in 2011.
- **College Ridge** at Skyline College, which has 30 units, is in the final construction phase and will be opening in late summer 2022.

Residents are eligible to live in the complexes for up to seven years and are charged affordable, below-market rental rates to allow for residents to save money to put toward a down payment for a home or for future housing needs.

At recent Housing Corporation Board of Directors meetings, the Board has asked that consideration and guidance be given by the District's Board of Trustees, including in the following areas:

- Understanding/clarifying the purpose of the employee housing program. After 17 years of operations, and the turnover of District Board of Trustees members and Housing Board of Directors members, views, perspectives, perceptions and understandings as to the program may have evolved and/or shifted. The Housing Board is interested in clarity on the Board of Trustees' view as to the purpose of the employee housing program in the current context.
- Understanding the vision of the District in constructing (or acquiring) additional employee housing complexes. With the addition of College Ridge, the employee housing program will have 134 units of

- housing to offer to employees. However, there are nearly 250 employees on the waitlist for units.
- Understanding the vision for affordability as it pertains to the setting of rental rates. Current rates are less than 50% of market rate. As the Housing Board works to set and adjust rental rates for units, they are interested in the perspective of the Board of Trustees as to perimeters as to how high or low those rates should be.

It is asked that the Board of Trustees consider and discuss the items referenced above.

As further context, attached to this report is a summary presentation of the Employee Housing Program and the items on which the Housing Board is asking for guidance. Also attached as reference is a recent article from the San Mateo Daily Journal regarding recent rental rate activity.

DISCUSSION OF PROCESS FOR MODIFYING DISTRICT MASKING REQUIREMENT

Most experts agree that we have transitioned from the pandemic to endemic stage of COVID-19. However, it is clear that we can also expect seasonal surges and new variants. San Mateo County is well-positioned to respond given the county's high vaccination rate, low transmission rate, and the infrastructure that has been built to respond to COVID-19. The San Mateo County Community College District (SMCCCD) is also well-positioned to respond to future COVID-19 surges.

The State of California lifted the general statewide indoor mask mandate on March 1, 2022. The statewide mask mandate for K-12 schools and preschools was lifted on March 11. The County of San Mateo is alignment with statewide mask rules. Although the San Mateo County Community College District (SMCCCD) is not subject to K-12 masking rules, the District has generally followed K-12 practices regarding indoor masking.

The decision regarding masking requirements for K-12 institutions now rests at the local district level. Some San Mateo County K-12 districts have continued to require indoor masking, while other districts have recommended that students, employees, and visitors wear masks while indoors, but have made the decision optional for all.

Currently, all students, employees, and visitors at any facility in SMCCCD are required wear masks while indoors, and the indoor mask mandate is in effect until further notice. Students and employees are to be commended in honoring the mandate, which has been in effect since the beginning of the academic year.

Conditions in San Mateo County have improved greatly and the District has an obligation to reconsider the current

mask mandate. Staff is raising this issue to the Board now for possible action at a future Board meeting. Among other things, staff will share the following information to assist the Board in making a decision concerning the mask mandate:

- Current San Mateo County Health Orders regarding indoor masking requirements
- Current San Mateo County Health COVID data
- A survey of current and expected masking requirements for other local community college districts and local CSUs.
- A survey of current and expected masking requirements for local school districts
- A brief review of District COVID mitigation strategies
- A summary of documented on-site COVID transmissions since March 2020.

Also, the administration plans to engage college and District stakeholder groups to gather feedback on lifting the indoor mask mandate

Staff requests Board direction and guidance regarding any other information to assist the Board in making a decision regarding the indoor mask mandate.
