ACCEPTANCE OF GRANT FUNDS FROM THE NATIONAL SCIENCE FOUNDATION'S SCHOLARSHIPS IN STEM FOR SKYLINE COLLEGE'S IMMERSE IN STEM PROJECT

On August 1, 2022, Skyline College was awarded a grant in the amount of \$1,498,855 from the National Science Foundation for the Innovative and Meaningful Mentoring to Enhance Retention, Success, and Engagement (IMMERSE) in STEM project. The funding period for this grant begins January 1, 2023 and ends on December 31, 2027.

The Innovative and Meaningful Mentoring to Enhance Retention, Success and Engagement in STEM (IMMERSE in STEM) project is designed to (1) increase the number of low-income, academically talented students in STEM disciplines at Skyline College who attain a STEM related associate degree or transfer to four-year universities to pursue STEM-related baccalaureate degrees; (2) develop an innovative mentoring program combining existing campus resources, as well as evidence-based methodologies to train mentors and create a cohesive multi-layer mentorship of peers, faculty and industry contributors; and (3) study the contribution of scholarships, curricular, and co-curricular activities to the recruitment, course completion, retention, degree attainment, and transfer of students traditionally underrepresented in STEM study and the STEM workforce.

First-year students will enroll in Skyline's cohort-based learning communities which incorporate accelerated and/or contextualized math and foundational science instruction, advancing students beyond common attrition points. This grant will award 90 (ninety) scholarships in the amount of \$10,000 each amongst four cohorts supported over a five-year period, to 30 students as they progressively deepen their commitment to a STEM pathway and advance toward a degree or transfer within six semesters. Participating students will engage in a set of core program elements, the impact of which will be tested through evaluation: (1) embedded tutoring; (2) Academic Excellence Workshops (AEWs); (3) peer, faculty, industry mentoring; (4) academic, career, and transfer advising; (5) STEM/MESA Center access; and (6) STEM pathway retention support.

INTERIM POLICY FOR SB893 FEE WAIVERS

Senator Josh Becker (13th CA Senate District) introduced Senate Bill 893 (<u>SB 893</u>), co-authored by Assembly members Kevin Mullin and Marc Berman, on behalf of the San Mateo County Community College District (SMCCCD) on January 31, 2022. SB 893 worked its way through the legislative process and has been passed by the State Senate (with amendments from committees), passed by the Assembly (with amendments from committees), and passed again by the Senate with concurrence. UPDATE ON STUDENT HOUSING GRANT APPLICATION

In the FY 2022 state budget state budget, \$2 billion was allocated (over three years) to fund grants to support the development and expansion of affordable housing at California's community colleges and universities. Half of the funds (\$1 billion) were designated for the state's community colleges. The state Department of Finance was charged with designing and administering a grants process and making recommendations to the Joint Legislative Budget Committee (JLBC) about projects to fund.

At the direction of the Board of Trustees, staff submitted a grant application for \$98.5 million, which would have funded a project at the College of San Mateo (but serving students from Skyline College and Cañada College as well), for a 144,000 square feet student housing development, serving nearly 500 students.

On March 1, 2022, the Department of Finance (DOF) issued the attached letter of recommendations to the JLBC. In their recommendations, they recommended that the San Mateo County Community College District be awarded a \$200,000 planning grant and they further determined that the District's proposal was ineligible for funding. District staff disagreed with this assessment and recommendation of the Department of Finance and the Board, at its March 23, 2022 meeting, authorized staff to pursue a formal appeal of the recommendation. Staff worked with the District's local state legislative delegation to lodge a formal protest, and though not successful in moving the District's project to the funded list, the concerns raised by the District were received and echoed in remedies in the FY2023 state budget.

The District plans to reapply through a new grant process for FY2023 dollars.

Staff will provide an update to the Board of Trustees about the grant process and the District's proposal framework.
