PERMANENT CHANCELLOR RECRUITMENT

At the September 13, 2023 Board of Trustees Regular Meeting, the Board approved the retention of R.H. Perry as the search firm for the Permanent Chancellor recruitment, the tentative timeline, and the composition of the search committee. The Board agreed to provide Staff and the Search Consultant with a specific salary for the job profile instead of a range.

Before proceeding with the next phase of the search process, Staff and Search Consultant R.H. Perry require Board action on the following:

- 1. Appointment of trustee to the search committee;
- 2. Appointment of community member to the search committee;
- 3. Determination of salary for the job profile and marketing materials.

CONSIDERATIONS FOR CLASS SIZE AND CLASS CANCELLATIONS

It is recognized that the District's current Board Policy addressing class cancellation needs careful consideration and revision. Generally, the current permanent policy provides the guideline (based on minimum class size) to cancel classes with fewer than 20 students. It also requires the District to be efficient and it provides some guidance for flexibility. In addition, each of the campuses created student-centered class cancellation guidance documents to support the flexibility of the current policy which are attached.

The District has a unique opportunity to work together on a collaborative solution. The Interim Chancellor has invited the formation of a work group that includes administrators and faculty to consider a new approach, potentially rooted in emerging best practices in class cancellations related to *maximum class size*. The challenge for the work group is to agree on a solution that faculty and administrators can recommend to the Chancellor *together* as a best practice.

Included in the Board Packet is a report for the purpose of edifying the District and our constituencies about the possible impacts of the District and Board of Trustees' decisions regarding class cancellation, and uniquely invites input from our constituent groups in advance of the upcoming study session. At this Study Session, staff will broadly present concepts that impact our decision-making on class cancellation and invite our constituent groups to be a part of the discussion with the Board of Trustees.
