RECEIPT OF DISTRICT'S INITIAL CONTRACT REOPENER PROPOSALS TO THE SAN MATEO COMMUNITY COLLEGE FEDERATION OF TEACHERS, LOCAL 1493, AMERICAN FEDERATION OF TEACHERS, AFL-CIO AND SETTING OF PUBLIC HEARING

The current collective bargaining agreement between the District and San Mateo Community College Federation of Teachers, Local 1493, American Federation of Teachers, ALF-CIO requires reopening the contract to negotiate two articles: Article 6 and Article 15. The District's Memorandum of Understanding re: Part-Time Faculty Health Insurance Pilot Program requires the parties to reopen negotiations to explore whether to extend the Memorandum of Understanding.

Government Code Section 3547 (from the Educational Employment Relations Act") provides that:

- (a) All initial proposals of exclusive representatives and of public school employers, which relate to matters within the scope of representation, shall be presented at a public meeting of the public school employer and thereafter shall be public records.
- (b) Meeting and negotiating shall not take place on any proposal until a reasonable time has elapsed after the submission of the proposal to enable the public to become informed and the public has the opportunity to express itself regarding the proposal at a meeting of the public school employer.
- (c) After the public has had the opportunity to express itself, the public school employer shall, at a meeting which is open to the public, adopt its initial proposal.

As required by the Educational Employment Relations Act, staff is submitting the accompanying District reopener proposal to the Board before holding a public hearing on the proposal.

RECEIPT OF INITIAL CONTRACT PROPOSAL FROM THE SAN MATEO COMMUNITY COLLEGE FEDERATION OF **TEACHERS, LOCAL 1493,** AMERICAN FEDERATION OF TEACHERS, AFL-CIO TO THE DISTRICT AND SETTING OF A PUBLIC HEARING

The current collective bargaining agreement between the District and San Mateo Community College Federation of Teachers, Local 1493, American Federation of Teachers, ALF-CIO (AFT) requires reopening the contract to negotiate two articles: Article 6 and Article 15. The District's Memorandum of Understanding re: Part-Time Faculty Health Insurance Pilot Program requires the parties to reopen negotiations to explore whether to extend the Memorandum of Understanding.

Government Code Section 3547 (from the Educational Employment Relations Act") provides that:

- (a) All initial proposals of exclusive representatives and of public school employers, which relate to matters within the scope of representation, shall be presented at a public meeting of the public school employer and thereafter shall be public records.
- (b) Meeting and negotiating shall not take place on any proposal until a reasonable time has elapsed after the submission of the proposal to enable the public to become informed and the public has the opportunity to express itself regarding the proposal at a meeting of the public school employer.
- (c) After the public has had the opportunity to express itself, the public school employer shall, at a meeting that is open to the public, adopt its initial proposal.

AFT has submitted an initial reopener proposal to the District, which staff transmits with this report to the Board. This is done before holding a public hearing on the proposal as required by the Educational Employment Relations Act.

FIRST READ OF REVISIONS TO CHAPTER 3 OF BOARD POLICY

Beginning in the 2021-22 academic year the District initiated a project to review and recommend updates to all SMCCCD Board Policies. The overall goals of this project are to: 1) ensure that all SMCCCD Board Policies are current; 2) that board policies are easily accessible; and 3) that a system is implemented to ensure systematic and regular updates.

The Board of Trustees reviewed and adopted revised Chapters 1 and 2 at its regular meeting on November 29, 2023. Staff has published the new policies on the BoardDocs platform and they are easily accessible and available to the public. Once the board has reviewed and adopted all seven chapters, staff will share a system for regular updates.

At that time, the Board prioritized the next chapters for review: Chapter 3 (General Institution) and Chapter 7 (Human Resources).

DISCUSSION OF MISSION STATEMENT AND VALUES STATEMENT

The Accrediting Commission for Junior and Community Colleges (ACCJC) and Board Policy 1200 requires a regular review of the District's mission statement. At its regular meeting on October 25, 2023, the Board approved staff's request for a study session on funding for District-wide capital improvement and repair/renovation projects. At that board meeting, staff provided **general historical perspective** regarding three General Obligation Bond Measures, including the latest Measure H in 2014. These bonds have allowed the District to advance three significant capital improvement plans resulting in the modernization of our campuses and provide spaces where our students and communities can thrive. This funding helped us to complete approximately 80% of the need. Now that Measure H funding is soon expiring, we need to have a strategy for funding ongoing infrastructure replacements and any necessary future capital improvements.

Staff also shared information on our *Fund 4 Balances*. Campus Presidents and the District were asked to create a prioritized list for campus and District needs and allocate all of their one-time Fund 4 balances (\$101M) to those needs over the next two to three years. Their priorities are aligned with identified projects in the Facilities Master Plan, the 5-Year Capital Outlay Plan, and the campus Education Master Plans. Additionally, the District team was asked to create a master priority list based on the Presidents' prioritization work and allocate other available one-time funds (\$174M). (See attached report from October 25, 2023).

At that time, we asked the Board for a study session to seek guidance from the board in how to address the staff *identified funding shortfalls* in both short-term funding for capital improvements and scheduled maintenance needs over the next two to three years and to help derive a long-term strategy for scheduled maintenance and capital improvements, including infrastructure replacements.

At this study session, staff will review the short-term priorities, and the long-term need, and present a strategy with possible solutions for discussion and board quidance.
