#### SECOND READ OF REVISIONS TO CHAPTER 3 OF BOARD POLICY

Beginning in the 2021-22 academic year the District initiated a project to review and recommend updates to all SMCCCD Board Policies. The overall goals of this project are to: 1) ensure that all SMCCCD Board Policies are current; 2) that board policies are easily accessible; and 3) that a system is implemented to ensure systematic and regular updates.

The Board of Trustees reviewed and adopted revised Chapters 1 and 2 at its regular meeting on November 29, 2023. #### DISCUSSION OF MISSION STATEMENT AND VALUES STATEMENT

#### Mission Statement

The Accrediting Commission for Junior and Community Colleges (ACCJC) and Board Policy 1200 requires a regular review of the District's mission statement. At the Board's retreat in July, 2023, the Board directed the Chancellor to bring forth a review of the mission statement, and set this as a goal in the adopted board goals.

At the Study Session of February 3, 2024, the board provided feedback to staff after reviewing the first draft of the Mission Statement. The Board has been provided a new draft based on the feedback given on February 3, and has been given "homework" time to review and suggest further revisions based on a review of the current mission statement, the mission statements of the State Chancellor's office and of the three campuses. At this meeting, the Board will have its second conversation and provide guidance to staff for its final mission statement expected to be adopted at the next Regular Meeting on March 27, 2024. The current proposed Mission Statement is as follows:

#### We put students first, focus on equity, and transform futures in the communities we serve.

We achieve this by:

- Removing barriers to student access by investing in free college for San Mateo County residents in need.
- Ensuring student achievement and academic excellence by offering equitable and supportive learning environments.
- Transforming futures by focusing on completion so students can thrive in local and global careers.

#### <u>Values</u>

In addition, and in accordance with the adopted Board Goals, the board can provide further feedback on a draft values statement to include support for Board Goal II: **Reinforce a thriving and positive-oriented workplace where employees feel supported in professional growth and innovation.** The Board was given an opportunity to review the below list of values and provide feedback. Based on feedback provided, staff will prepare for a final read and further discussion of a District's values statement at the next Regular Meeting of March 27, 2024 with a planned final adoption at its next regular meeting in April.

The list of values currently under consideration are:

- Access We believe all students have a right to higher education. We are committed to providing free college for San Mateo County residents in need.
- Accountability We strive to make data-informed decisions and hold ourselves accountable as District leaders.

#### REVIEW OF ADMINISTRATION PROCEDURES CONNECTED TO CHAPTERS 1 AND 2 OF BOARD POLICIES

At the Study Session on February 3, 2024, the Board respectfully requested to see the Administrative Procedures (APs) connected to the Board Policy Revision Project. Current Board Policy 2410 states in part:

#### Paragraph 7:

Administrative procedures are to be issued by the District Chancellor as statements of method to be used in implementing board policy. Such administrative procedures shall be consistent with the intent of board policy. Administrative procedures may be revised as deemed necessary by the District Chancellor.

#### Paragraph 8:

The District Chancellor shall, on an annual basis, provide each member of the Board with any revisions since the last time they were provided. The Board reserves the right to direct revisions of the administrative procedures should they, in the Board's judgment, be inconsistent with the Board's own policies.

As the Board continues it Board Policy project, the Interim Chancellor will follow adoption of Board Policies with a review and revision to the APs. The "draft" APs for the now-approved policies contained in Chapters 2 are attached and are currently under review by the Interim Chancellor. [Please note: There are no APs for Chapter 1]. When the review is complete, the final versions will be publicly posted and shared with the Board of Trustees.

#### EQUAL EMPLOYMENT OPPORTUNITY 2023 - 2026 DRAFT PLAN

#### **Background**

In July 2021, the Board of Governors of the California Community Colleges adopted new Equal Employment Opportunity (EEO) regulations to provide the necessary framework for more robust and accountable EEO programs. These regulations became effective October 20, 2022. The new regulations significantly change the requirements for drafting and submitting EEO plans. These changes include, but are not limited, to the following:

• District governing boards must review and adopt the EEO plan at a regular meeting where the plan is considered as a separate action item and not part of the consent agenda. (5 C.C.R. § 53003(a)(2))

• A district's draft EEO plan must be submitted to the State Chancellor for review at least 90 days before its adoption. The governing board must consider the Chancellor's comments on the draft EEO plan, if any, before adoption. (5 C.C.R. § 53003(a)(4))

• The plan must be developed in collaboration with the district's Equal Employment Opportunity Advisory Committee established according to section 53005. (5 C.C.R. § 53003(a)(1)).

The District's plan was developed in collaboration with the District's EEOAC, and the draft plan was submitted to the State Chancellor's Office and feedback was returned to the District in November 2023.

Staff expects to bring the final plan for adoption at it's next regular board meeting of March 27, 2024.
