### What can I do during Open Enrollment?

- Enroll in coverage
- Add/Delete eligible dependent(s) from your plan (medical, dental and vision)
- Cancel coverage
- Change health plans (medical or dental)
- Enroll/Re-Enroll in a Flexible Spending Account (**FSA**) plan.

\*\*REMINDER: Re-enrollment for FSA is required every year, enrollment does not automatically carry over.\*\*

### What are the Dental Plan Options?

#### DeltaCare Plan

- Must receive all dental care services from a dentist who
  participates in the DeltaCare network (please note that
  the network is very limited).
- Most services will be covered at 100% with no out-ofpocket costs with the exception of some major services.
- Plan includes orthodontic care; services must be provided by a DeltaCare orthodontist.

#### Delta Dental Plan PPO

- Flexibility to seek dental care services from any dentist, in or out of network.
- Receive the most savings by seeing a Delta Dental PPO Network Provider or a Delta Dental Premier Network Provider.
- Responsible for paying any charges over Delta Dental's approved fees when out-of-network.
