# Accreditation Highlights - Standard 2: Student Learning Programs and Services

Accreditation Standard 2 states the "institution offers high-quality instructional programs, student support services, and library and learning support services that facilitate and demonstrate the achievement of stated student learning outcomes."

This is an important aspect of our accredited status – that throughout the institution, we are paying attention to the achievement of student learning. ACCJC has developed "rubrics" for evaluating institutional effectiveness. And, for Student Learning Outcomes (at the course, program and institutional levels) we are to be at the "Sustainable Continuous Quality Improvement" level. What does that mean? Here are the criteria:

- Student learning outcomes and assessment are ongoing, systematic and used for continuous quality improvement
- Dialogue about student learning is ongoing, pervasive and robust
- Evaluation of student learning outcome processes
- Evaluation and fine-tuning of organizational structures to support student learning is ongoing
- Student learning improvement is a visible priority in all practices and structures across the college
- Learning outcomes are specifically linked to program reviews
