# III. Student Equity Plan

SSPC reviewed and discussed a section of the Student Equity Plan.

There are several components to a Student Equity Plan; access component, course completion component, persistence from Fall to Spring, degree and certificate completion, transfer and basic skills and ESL. We need to look at the data to be sure we are representing our populations.

Comments included: Connect community by using President's Circle Develop enrollment management strategies Look more closely at Pacific Islanders, Asians and Philippines. Are these thee populations linked together in the data? Cañada has created and cultivated a Hispanic population where they feel comfortable and can succeed. We want to do the same thing with other populations Why does Cañada not have a Puente program? We need support for males of all cultures at Cañada

The Strategic Enrollment Group will look at ways to improve male involvement.

The Student Equity Plan will be ready go to PBC by May 15.

### **IV.** Delineation of Functions

Student Services Planning Council reviewed the accreditation document "Delineation of Functions" brought to Cañada from the District Office. SSPC found some areas that they felt should be Shared vs. College or District and those recommendations will be forwarded to the District Office.
