Waterbed Fans Enjoy 'Obvious Benefits'

The middle-aged woman, a picture of society-page perfection, is not acting quite as dignified as she looks. After walking into the store — a waterbed store — she has jumped onto a piece of merchandise.

"Wheeeeee!" she exclaims to her husband, who is standing by holding onto the kiddies. "This is FUN!" The husband grins a sheepish grin, and gingerly tries out the bed. He is pleased with the prospect of nights on the waving mattress. Within five minutes the couple have bought the bed, specifying that it be delivered "As soon as possible."

Mac McConnell, owner of the store, is happy with the sale, but not surprised. "Once people try out the beds, it's easy to sell them. I don't pressure people because I don't have to." McConnell's method of selling waterbeds appears to work, for throughout the afternoon a steady stream of customers file in and out of the store. Many buy one of the three types of waterbeds displayed on the floor, with almost no urging from McConnell. One attractive young woman, asked why she and her husband were purchasing the bed, winked and said, "For the obvious benefits." While she spoke, her husband was lying on a bed bouncing up and down.

Waterbeds are a relatively new phenomenon in the United States, approximately three years old. The beds themselves, however, are not new.

Waterbeds were first used in

English hospitals ten years ago. Bedsore and burn patients were given waterbeds to rest on, as, unlike regular mattresses, equal pressure is distributed on all parts of the body. Because of this, blood flow to the extremities is unaltered, and bedsores will not develop.

Waterbeds are now being used in American hospitals for the same reason. In a letter concerning the medical uses of waterbeds, Dr. Richard Siegel a member of the plastic surgery unit at Stanford Medical Center, said, "We are currently investigating the water bed for use in plastic surgery patients, especially patients with paraplegia."

Acceptance in the medical world aside, waterbeds are becoming increasingly popular for non-medical reasons. People simply like to sleep on them. There are some possible inconveniences; the approximately 220 gallons of water which must be used to fill the bed can cause a problem when a leak is sprung. Leaks can be patched quickly, however, without emptying the mattress. Another potential problem is the growth of algae in waterbeds. When filled for a long period of time, and exposed to direct sunlight for a long period of time, McConnell warned that beds can become "Pretty sludgy" if no precaution is taken against the mossy growth. Algae can be prevented, however, by dumping a packet of translucent, blue, anti-algae crystals into the bed. Crystals are sold at most waterbed stores on the peninsula.

The possibility of overloading the bed with human bods is unlikely, although a concern about overloading was expressed by several hesitant customers. "If a waterbed is properly made,"

McConnell said, you could park a car on it without damaging the mattress."

Only one accident has occurred in the store since its opening; a tot pulled the plug on a showroom

waterbed, which resulted in a salesman who was literally 'all wet.' McConnell says he had no real trouble plugging up the leak, however. "The kid was just delighted with what he'd done," McConnell recalled. "However, I was not too terribly happy." Otherwise, there have been no incidents in the store which led to liberation of the liquid stuffing in the beds.

Perhaps more significantly, there have been no complaints from customers who wanted to return to ordinary mattresses after trying out waterbeds. "We have had some complaints from people who got mattresses with a defect," McConnell recalled, "But that is something that happens at the factory, not here. We took their mattresses, gave them new ones, and they were happy."

While McConnell is speaking, a couple wanders in. Sitting down on a bed and feeling the undulating waves, the man smiles.

Rally 'Fly-by' Pilot Questioned

At the Anti-war rally of October 31, here at Canada, during the Guerrilla Theater portion of the show, Carl "Mike" Hoeck, flew an airplane near the audience to dramatize the way villages are bombed in Vietnam. When his plane landed at San Carlos airport, there were several policemen waiting to inform Hoeck there had been a complaint lodged against him for allegedly flying "...over an open assemblage of people" by administrative assistant, John Rhoads.

Hoeck, a Canada graduate, and veteran of the War in Vietnam, related his experiences of being familiar with some of the 20,000 American soldiers who got killed in Vietnam within the last four years. He said, "I tried to ignore my (wartime) experiences. It didn't work. I thought I could do something good by showing the people how the technological and mechanical input of America kills people."

Hoeck will have a hearing, conducted by the Federal Aviation Administration (FAA), in which he hopes to be given a maximum sentence of a "Six month suspension of my license" as he puts it, and went on to say "I would appeal a one year suspension, or the total revocation of my license."

Russ Bissonnette, Controller of Activities, spoke for the entire

student council when he said "We know that the agencies involved were waiting for an infraction". He went on to say "The crowd wasn't in danger. There might have been an infraction of the regulations but the plane broke off to the West, and maintained a safe altitude at all times. We feel the complaint is a political move by any or all of the administration, the Board of Trustees, and a Federal organization to halt further activities by the Vietnam Veterans Against the War."

Hoeck's FAA hearing will be this Friday, and to counter-balance the reports filed by the San Mateo County Sheriff's Department, the Highway Patrol, and Rhoads, against him, Hoeck came back to Canada and made a plea for letters from people who attended the rally to explain whether or not they were threatened by the airplane fly-by. There were no less than 75 letters submitted all of which were written by people who did not feel intimidated by the aerial exercise.

Words of Jesus Hailed On Campus

Whatever we believe or disbelieve concerning the concept of God, we all have some sort of idea on this subject. A Cañada College student, Al Kenyon, is what many might call a "Jesus Freak," which implies that he has many ideas on the subject.

Kenyon was recently asked by philosophy instructor, Frank Young, to speak to one of his classes on the subject of God. In the following interview with Kenyon, he said that "The Lord took Frank's heart," and as a result, Kenyon was invited to speak.

Kenyon's belief of a universal God is expressed in these words:

"Every human being was created to have a fellowship with God. The only way you can get that is through Jesus Christ. Until you believe in Jesus Christ, you're not aware."

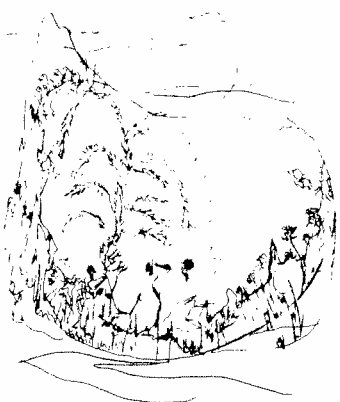
When asked how he personally found God, Kenyon replied:

McCloskey Debates Stewart

A small group gathered at Canada's pit last thursday to hear Republican Pete McCloskey and Democrat James Stewart debate for the 17th Congressional district's seat.

The incumbent McCloskey, who was running for his fourth term, was first to speak. Looking cool and confident he opened up by giving a rundown of his campaign issues. His first point was the environmental issue. He stated he was voting for proposition 20, the Coastline Initiative and continued to say, "I strongly supported seven major conservation bills this year. The Wildlife Refuge in Palo Alto went through my committee."

McCloskey also advocated an "opening up of the political system," meaning he is against government officials withholding information from the public and cited the Watergate Incident as an example. He then proceeded to say he would not support president Nixon in the upcoming elections, his reason being the Vietnam war. McCloskey feels he is justified in the support of the B-1 Bomber in order to keep up a balance with other major powers in defense but feels there should be "Limitation agreements" between other countries and the U.S. McCloskey finished up by attacking the seniority system in

Editorials

The Love of Killing

Early paleolithic man feared Nature and the gods he devised, so to comfort these fears, elaborate rituals were also devised in hopes of appeasing angry deities. One of these rituals was the sacrifice of human life. Today we do not condemn these ancient pagan practices because we realize that the resources of information that we enjoy today were not available then.

So let's look at our current values and see how far we have progressed in the last ten thousand years. Last Tuesday California voters chose to preserve the age old custom of human sacrifice by passing proposition 17, the death penalty. The measure passed by a greater margin than any other proposition, in spite of our relative intellectual sophistication. It appears the practice of avenging crimes by death is a deeply rooted cultural value and perverse obsession that provides nothing to be proud of in a modern society.

Unlike primitive cultures, our society has devised rationales in support of the death penalty which go beyond and cover up our basic obsessions with death. So we say that the death penalty is necessary in deterring crime. This allows us to ease our consciences as well as appeasing angry deities.

Unfortunately for those who pretend to believe their convenient rationale, there has never been any statistical evidence to substantiate it. If the death penalty did serve as a crime deterrent it stands to reason that crimes would go up in states where the death penalty has been eliminated — but it hasn't.

Contrary to what death proponents say, there is even some indication that the death penalty actually fosters violent crime. There are those who are so psychologically confused that they commit acts which would allow them entry into the gas chamber as an "easy way out". The death wish, common among disturbed individuals, should not be rewarded, but treated.

But we have all heard these arguments, and it does little good to pontificate over them now. The question we should ask ourselves now is why has the need for institutional homicide become so important to so many Californians for so long. "We say two wrongs don't make a right," and turn the other cheek, and even a very vehement "Thou shall not kill". Yet our value for legalized murder has superceded the traditional so-called Judeo-Christian value from which our society is supposedly founded on. Apparently this perverse need to kill has endured the last ten thousand years with little opposition, in spite of the supposed value for life we say we have.

'Four More Years'

Now that America is subject to four more years under Richard Nixon, we must consider the effects of this predicament.

Will there be peace in Vietnam? Will the unemployment crisis improve? Will the rate of inflation slacken? Will taxes be lowered? Will the President rectify these problems? What, exactly, does he plan to do, now that his power has been extended for another term? These questions, along with many others, must be answered.

Throughout Nixon's second term in office, we must watch him closely to be certain that he carries out his many obligations to the American people. It is no surprise that Mr. Nixon is quite capable of deceiving the people of America.

If Mr. Nixon fails in his obligations, it is our responsibility as Americans to take whatever steps necessary to obtain satisfactory results. These steps may include legislation through the channels, or they may take on the characteristics of a revolutionary movement throughout the land.

We believe that the time has come for Mr. Nixon to live up to his promises and obligations to America.

Retraction

In last week's edition of The Newspaper, a major portion of the Jane Fonda anti-war rally article was inadvertently omitted due to a printing error.

As a result, a quote which appeared to be attributed to Peter Sears was actually made by rally organizer Frank Milatzo. The quote went as follows: "The anti-war movement got a hold of me, and I've been straight ever since." Milatzo was referring to his heroin addiction acquired in Vietnam.

Also omitted were portions of the Jane Fonda speech as well as Tom Hayden's departure for Hanoi where he claimed to be arranging for the return of some American POWs.

Minorities Accuse Duke Of 'Unresponsiveness'

OPEN LETTER
TO PRESIDENT OF
CAÑADA COLLEGE
Dr. James Duke:

The primary purpose of this letter is to make another attempt to open the channel of meaningful communication between you, the President of Cañada College and a group of very seriously concerned minority faculty and staff — commonly referred to as the Minority Faculty and Staff — and to impress upon you in writing — in order to preclude rumors — some of our concerns regarding Cañada College and its commitment to the total college community, and including the minority community.

Permit us to state fairly and frankly that since you assumed the duties of president of the college, meaningful communication between you and the Minority Faculty Committee has been at its best, fragmentary, incomplete, and alarmingly unsatisfactory.

Perhaps you ask why we continue to show such concern. Well, it's simply that we cannot afford the luxury of uninvolved and apathy; nor are we so irresponsible that we are content to accept a state of benign neglect. Certainly it is painfully obvious to us that subtle and overt forms of racism, like cancer, do not go away simply because its victims grow tired of fighting its ever pervasive growth. It would be so very easy for us, like perhaps many others on this and other college campuses to be lulled into a para-comfortable hypnotic state of pretending that all is well. Far from it. All is not well, and as minorities we cannot and will not pretend that our lot is a satisfactory one. We do wish that we were such an integral part of this college that it would no longer be necessary for us to spend long hours, above and beyond our regular duties in an effort to make this insensitive institution responsive to the basic needs of its immediate family, faculty and staff, and the total community (particularly the minority community). It should be well understood that we will not grow weary of meeting long hours and working to make this college live up to its stated and indeed legal obligation to this community and particularly our minority community. We simply cannot and will not leave the educational fate of our minority community singularly in the hands of those who have been so poorly prepared (both in terms of training and experience) in assessing and administering the educational needs of the minority community. We must add here that this lack of preparation or experience is

certainly not the fault of any single individual. The institutions of higher education which trained most of the faculty, administrators and staff have been, as unaware of and insensitive to the educational needs of minorities as Cañada College seems to be today. These institutions of higher education were then and still are in all too many instances busy trying to ignore the fact that minorities are a part of their community. These institutions hope desperately that the minorities and/or their problems will go away. We, the Minority Faculty and staff will expend all possible energy to help solve the education problems of the minority community, for we are positive that with honest cooperation and assistance from the office of the president of the college and other administrators, faculty and staff, Cañada college will be more than an abstract palce up on the hill, physically and educationally far removed from the community, particularly the minority community it is mandated to serve.

Thus, in the interest of the college community and specifically the minority population of this community, we, the Minority Faculty and Staff call upon you, the president of Cañada College, to respond in a meaningful and direct manner to the following items, in writing, for immediate implementation.

A. ETHNIC STUDIES

In the areas of Ethnic Studies the Cañada College administration must continue to meet the moral challenge of becoming totally aware of the contribution of ethnic minorities in the following ways:

1. Insure the implementation of those ethnic studies courses already submitted and approved by the Board of Trustees.

2. Recruit and hire minority personnel qualified to teach the courses which have become a part of the Ethnic Studies curriculum.

3. Maintain and further expand Ethnic Studies courses and specifically include the implementation of a program for Native Americans.

4. Provide students with the option of substituting minority courses which will satisfy the American Institutions Requirement, an option presently denied them.

Only by total commitment and dedication to the above by the President and his administrative staff can this college meet the needs of the students in our Ethnic Studies program on a sound basis.

B. FINANCIAL AIDS OFFICE

That federal guidelines be scrupulously followed regarding total number of personnel

employed in Financial Aids office and the total amount of funds disbursed by subject office.

We feel that the administration has not dealt with us in good faith in the staffing of the Financial Aid position. This position has been vacant for 7 months. We look upon these procrastinations as a breach of promise; therefore, we insist that staffing of this office be implemented immediately in accordance with guidelines established by the Department of Health, Education, and Welfare. We further insist that this office be filled by a non certified minority person. It is the feeling of the minority faculty that we have met all of our obligations to this school and its administration in following the appropriate "chain of command" in our endeavor to fill this position. (We now feel justified in taking any further steps which we deem necessary in seeing that this office is filled.)

C. PROJECT-FUNDED PROGRAMS

Any ongoing and all future programs courses, projects, etc., on or off campus, which are partially or fully supported by local, state, or federal funds which have implications for ethnic minorities must have minority faculty input in all phases — inception, planning, hiring, implementation, and evaluation — in order to insure that such projects will truly be beneficial to the communities purported to be served.

D. STUDENT DEVELOPMENT PROGRAM

To insure that the program continues to maintain its original goals it is necessary to:

1. Increase much-needed supportive services to students.

2. Upgrade secretarial position to a level that is at least comparable to other Cañada College Administrators' secretaries.

3. Maintain the current staffing pattern of Student Development Program.

E. That recruitment and hiring of ethnic minority administrators, faculty and staff be stepped up immediately.

F. That recognition be accorded — by programs, activities, and college-wide celebrations — to historically important persons and events relevant to minority communities.

G. That offerings from the Fine Arts Division — art, drama, music, etc. — reflect the diverse talents and accomplishments of various ethnic minorities in this country.

H. That we serve notice to the administrators at Cañada College that ongoing evaluations will be conducted by the minority faculty and staff. However, we hold the top administrator, the president of this college, accountable for the actions of all administrators under him.

I. DEAN OF MINORITY AFFAIRS

In order to implement the above we demand the creation of a position titled Dean of Minority Affairs. This will be a full-time position involved in all aspects of Cañada College in order to help all employees and especially the minority constituents. The

accepted Jesus Christ, I was blind, but now I see."

Kenyon spoke about Jesus, saying:

"God personally entered into a body in the likeness of man, and lived a perfectly sinless life, so as to take our sins upon his sinless body. The perfect took the place of the imperfect. He was not only humiliated by the people, he was also bodily murdered. This is the glory of God."

With a note of confidence in his voice, Kenyon told of another appearance of God.

"He is going to reappear," said Kenyon. "It won't be for a while, but it will happen in this generation. Before he comes back, those who know God through Jesus will be snatched out of the world. Immediately following, will be seven years of Hell, worse than the world has known, or ever will know again. There's going to be destruction, famine, pestilence, disease, and human massacre. For the first three and a half years, the wind will cease to blow. The time will come when a piece of bread can buy a bag of gold."

Kenyon made it clear that these words were not his philosophy or religion, nor are they based on feelings.

"What it is based on," said Kenyon, "is the fact that God made a promise. I trusted this promise and, as a result, I have the correct feelings of joy."

Kenyon said a great deal more than these few paragraphs imply, but the basis of his ideas are evident. Congress. He said "A minority of the Congressmen hold the majority of the power."

When Stewart spoke, he focused mainly on attacking McCloskey. He criticized McCloskey for voting against equal rights and in favor of the B-1 Bomber. Stewart went on to stress welfare reform and the war on poverty which he feels are major issues overlooked by his opponent. He advocated elimination of the draft by saying, "The power to wage war is in the power to draft." He also advocated unemployment insurance for farm workers. Stewart ended his short speech by saying he had "Lost confidence in the nation to deal with problems" and the Nixon Administration had "Lost control of the democratic system."

McCloskey and Stewart were in agreement on two issues. Both were against propositions 22 and 19. Reasons for the No vote on 22 were not given as no one questioned the candidates stand but they both agreed there wasn't enough data accumulated on the long-term physical effects of marijuana to know it's true effects on users.

'Enemy' At Skyline

Skyline College Drama Department is presenting Henrik Ibsen's play "An Enemy of the People" December 6th through the 9th in the main theatre at 8 pm. The play is quite representative of Ibsen's work and although it was written in the late 1800's, still retains contemporary significance.
