Anna stated that they have been amended to include both live productions and radio productions in conjunction with the broadcast and electric media department at CSM. Gloria asked about the CSM collaboration. Anna stated that the launch of the partnership was to take place this semester, but COVID shifted the timeline. Anna reported that her students would rehearse a script on zoom, and record using the microphones available at CSM. Depending on social distancing guidelines at the time, students will be able to either record at the CSM studio, or microphones will be mailed to them to complete the recordings from home. The dialogue will be recorded, and CSM course's students will create a soundscape for the show, and a fully produced audio drama will be created. Chris asked what the first production would be. Anna shared that it was a piece she had written which was a post-apocalyptic heroic drama about young people trying to make their way in a failed state.

• FITN 308.1 - Hiking and Trekking for Fitness I (1.00) (New Course)

Katie Perkins presented on behalf of the above course. Regarding FITN 308.1, Katie stated that this is a new course for the campus but not the district, despite the fact that it had not been taught for some time. Katie had been discussing the creation of this course for some time. One of the most popular classes is the online walking fitness class, and this course seemed like a logical follow up to the walking fitness course. Katie stated that there are numerous walking trails in the Bay Area, and it made sense to offer a course where opportunities are available for people based on the area. This course would also introduce people to hiking and trails specific to their area, exploring between ten and 16 places in their community, as well as topics including safety of hiking, and poisonous plants. This course is an extension of walking fitness, with the intent to introduce an exercise option of hiking with the potential for lifelong applicability. The course can be offered fully online or in person. Nick Carr stated that there have been questions in the past suggesting the course is too similar to the walking course, but he mentioned that hiking is a different culture altogether that is touched upon that is not addressed in the walking course. Lisa asked if sticks will be included, and Katie mentioned that they would be included and their purpose is to assist with stability. Gloria asked about how the class will be offered when it is in person. Katie stated that the course might initially be offered as a hybrid, including pre and post testing for fitness at the start and end of the semester. The middle of the semester would require 8 in person walks, where the class would meet one day a week and students would be provided with a schedule with times and locations. Katie mentioned that students would have to be able to travel to the locations of the group hikes, but that individual hikes would be allowable for certain weeks where students would choose a location from a provided list. If the course is provided completely online, the students are to download a tracking app that allows the instructor to see GPS, elevation, and distance of the hike. Maria asked if trail locations would include particular areas of the Bay Area. Katie mentioned that there are websites where you can enter your city or location and set a search for a particular mile radius that would include hikes within that specified area. Gloria mentioned that this course can be submitted in December for the CSU-GE area E and next June, the course could be submitted for UC transfer.

a. Chair's Report

- > District Curriculum Committee (DCC) Update
- AB 1460 signed by Governor Newsom requires CSUs to have an additional area requirement for ethnic studies; once the CSUs figure out their plan (expected: December 2020), our district (and all of the other community college districts) will need to figure out how to support students in meeting this requirement. Lisa mentioned that there is currently no representation on the Ethnic Studies subcommittee according to the website. Maria asked if Lezlee Ware was still a member of the Ethnic Studies Committee, and suggested Lisa reach out to her for clarification. Lisa stated that she would follow up. Maria commended the campus for typically being ahead in this area. Maria mentioned she can send the guidelines for ethnic studies requirements to Lisa for her review.
- All three campuses are proceeding apace with reviewing large numbers of DE addenda, each campus with a different process. Skyline, for example, requires each course submitting a distance education addendum to be put on the substantive agenda for discussion and approval. The DAS has set the goal of this academic year for getting the three campuses to figure out a process for aligning curricula across the district.
- Lisa shared that she learned a new phrase, "future proofing," which refers to looking at courses and approaching them in ways to ensure their sustainability. As we revise the CORs and add distance addenda, we are attempting to future proof them for future calamities.

b. Articulation Officer's Report

Articulation Report 9/25/2020

New Assembly Bill (AB) 1460 requires students in the CSU system to take an Ethnic Studies course to meet graduation requirements. Beginning 2021-22, the CSU General Education pattern will be revised to add a new Area F Ethnic Studies (3 units). CSU General Education Area D Social Sciences will be reduced from 9 to 6 units. Therefore the unit total of the CSU General Education will remain at 39 units.

AB 1460 defines Ethnic Studies as.... "an interdisciplinary and comparative study of race and ethnicity with special focus on four historically defined racialized core groups: Native Americans, African Americans, Asian Americans, and Latina and Latino Americans."

Community Colleges will likely be prompted to submit courses for the new CSUGE Area F Ethnic Studies this December, for approval dates effective Fall 2021. Here are the courses that currently satisfy Ethnic Studies for Cañada's local AA/AS Degrees:

José mentioned that 6 courses have yet to be submitted, and it does not matter if the courses will be offered in the spring as the committee still must comply with the state guidelines. Danielle provided that LCTR from her understanding was a CANVAS shell and asked if this still required the same process.

José clarified that LCRT 698 is a not for credit offering specific for tutoring purposes. Noncredit courses can be offered as distance education, but with this offering, supervision is required. In order for a tutor to tutor students and be supervised, it will be difficult. José mentioned that likely the only thing that can be supervised would be the JAMS offerings. Nick mentioned that one way to supervise the students is through a new software called Pronto and this is being explored. José asked that Lisa initiate an email to deans to have faculty submit the outstanding items to include on the next meeting agenda to be 100% compliant. Gloria clarified that CRER 430 will not be offered in the spring to address one of the outstanding courses, but that she will discuss with the appropriate faculty to remain compliant. Soraya asked if the course is being banked, if the DE addendum still needs to be submitted. José clarified that yes, this is still required and the course can be deleted later. Nick C. asked what the requirements for supervision are, and Nick D. clarified that line of site is the appropriate requirement, but we are attempting to explore how best to establish that in a visual world. José clarified that the supervisor also needs to meet minimum qualifications.

Nick mentioned that the focus is still currently DE Addendums. There are still a handful of people who have yet to submit appropriately. Currently, there are 6 outstanding, which may be a problem if these courses are attempting to be offered in the spring semester.
