 Addition and Deletion of Disciplines and course prefixes - Memo & Discussion: Addition of Funeral Service Education (FSE.), and deletion of Mortuary Science (MORT)

Doug Hirzel presented on behalf of this item. He mentioned that the name of the program is changing from Mortuary Science to Funeral Services Education because the name Mortuary Science had been presented to the committee as a

miscommunication from the previous Interim Dean who was reviewing the disciplines list rather than the accreditation manual. Mortuary Science is an archaic term and the accrediting body refers to it as Funeral Services Education. The name more accurately represents the interdisciplinary focus of the study, including Biology, Chemistry, Sociology, Psychology, Business, and Law. Funeral Services Education encompasses much more than simply the science. The industry as a whole is considered a hospitality industry, customer service, and providing services to those who are in need. The industry itself has been rebranded to provide a different impression. Doug reported that he will be proposing this program in two weeks to Curriculum Committee, and he would like to have the name changed at the current meeting in preparation.

Chris Burns asked what percentage of courses are sciences versus hospitality. Doug reported that the representation is likely close to 50/50 science and field work and other courses. Nick D. stated that he recalled part of the appeal of this program was beyond simply the small business model and how this may assist those in other fields and career settings. Nick asked if branding this exclusively to the business model may impact the ability to market the program to those seeking these courses for alternative career paths. Doug clarified that those familiar with the industry would be aware of the terminology shift, but the general public may not be aware of the distinction. Nick suggested that when promoting this opportunity to students, to be mindful of being clear of the extent of career paths this may potentially open for students. Doug agreed and mentioned that this would be marketed holistically, and that the change in name should increase the appeal to a larger population of students.
