3.2	Student Leadership and Shared Governance	Ta	10	<p>Discussion of effective student leadership in shared governance</p> <ul style="list-style-type: none"> Student Trustee Ta visited DAS to garner support for some sort of support for students vis-à-vis shared governance. Options she shared include a course on shared governance, a honors program added to an existing class, OER options, or a student club. Natalie asked if this class would be something students who are interested in shared governance or current student leaders (or both). Ta responded that she would like the faculty to make that decision though having both types of students would be ideal. Sarah mentioned that the Honors courses are interdisciplinary, which allows a broader range of faculty to teach the courses. Jessica recognized that a course would add costs and units to the students who take it, esp. international students. Instead, Jessica suggested noncredit and if not interdisciplinary, they would have to figure out which discipline it would fall under. Jessica also suggested independent studies courses. Kate mentioned that courses need instructors of record, a minimum enrollment of 10, and offered across all three campuses. David noted that courses take a long time to create and to get approved, so he suggested we focus on course content at the moment. Jeremy suggested that Lesly connect with local senates to get champions for creating the courses at the local campuses. In the meantime, he suggested a summer bridge program opportunity. Lesly asked if the best approach is to go to the locals or district senate. Jeremy responded that DAS is the best route since its membership includes the local senate leaders, who can take this back to their senates. Jessica said she will agendize this topic at the next DCC meeting. She also noted the GE implications of both regular and experimental courses and shared the requirements of independent study courses. She also shared that the Skyline COMM department is developing modules about effective communication. 	Discussion
