DESCRIPTION OF THE WORK: This project is part of our Modernization of Building 16 on the San Mateo College Campus. Implementation of SMART Technology in the renovated classrooms is the main scope of this work, which includes providing, installing and terminating network cabling from the classrooms to the new IDF on the first floor of Building 16. Surface mounted raceway, conduit, and concrete coring is already being installed and/or provided for under separate contract and therefore, not part of this contract. Fiber optic connection from the new IDF to Building 1 is also being provided for under separate contract and therefore, not part of this contract. The primary information source for the coordination of the electrical and telecommunication networking in the modernization of Building 16 is described in prototypical format per DES Architects + Engineers / TEECOM Drawings Sheets, dated 10/15/07.
