II. PRE-BID REQUESTS FOR INFORMAITON AND CLARIFICATIONS

A. **Pre-Bid Request for Information** from RFI Security Systems, Al Flores, on 12/12/05.

QUESTION:

I am in receipt of the Revised Addendum #1 Dated 12/7/05 and I need clarification on the C10 Electrical contractors who are pre-qualified for this project. On the list of the pre-qualified on the addendum #1, only Atlas/Pellizzari Electric and Del Monte Electric attended one of the mandatory Pre-Bid conferences per the sign in sheets. Is it correct that only these two electrical contractors will be qualified to submit a bid on this project?

RESPONSE:
