Ribbon Cutting: Cañada Building 9

On Monday, August 20th, Cañada College had its Ribbon Cutting Ceremony for the new Library and Student Resource Center. The building is the largest building constructed in the nearly 40-year history of the College. The Ceremony took place in the plaza in front of the new Library and Student Resource Center.

The 71, 000 square foot Library and Learning Resource Center

houses a state-of-the-art library open to the public, a student learning center, and an all essential student services under one roof. The renovated exterior quad area features a water fountain, a horse sculpture from acclaimed artist Deborah Butterfield, and a new amphitheater for campus activities.



Behind the scenes, Cañada Facilities Staff had a major part in preparing the site for the momentous event. The Engineering

crew assisted in placement of the horse sculpture one and a half weeks before the ceremony. The



Engineering crew also worked closely with electrical and mechanical contractors to make sure all systems were working in the building. The Custodial crew installed all garbage and recycling bins inside the building and stocked all the restrooms. The Grounds crew made sure the exterior area and landscaping around the building was pristine for the event.

**Skyline Facilities
Swing Move to Loma Chica**

On July 9 – 11, 2007, the Skyline Facilities Team moved their entire office and ware-



house operations to Loma Chica, an abandoned San Mateo County school building on the north

side of campus. Swinerton also moved to Loma Chica.

Weeks of preparation went into getting ready for the move and getting Loma Chica built for a maintenance facil-



ity. This relocation of a main-tenance facility was a 'first' for

the SMCCCD and no easy task.



It took two moving companies with a total crew of 20 personnel to make the move. Facilities staff moved the contents of Bldg 14 (office building) entirely by themselves in one day. 550 Crown moving boxes were used to pack and make the move. 306 cubic yards of debris were hauled away in support of the move or approximately 125 tons of "stuff" was discarded and/or recycled



Site improvements are continuously ongoing at Loma Chica as the Skyline Facilities Team gets settled and resumes 'Facilities Excellence' in their maintenance operations and support to the campus.
