

# Cañada College Scope of Work


- Replacement of 12kV campus main

- Complete online

- Two paths to C10 qualification
- Path 1 is for C10-licensed contractors on the District's 2011 pre-qualified contractor list
- Path 2 is for C10-licensed contractors not on District's 2011 pre-qualified contractor list

#### C10 Qualification Process – Path 1

2011 Pre-Qualified firms:

Bulk of application will be pre-populated with information from 2011 contractor application.

Complete the Supplemental Question:

"Have you successfully performed at least 2 power cutovers of 12kV or greater in an occupied facility in the last 24 months, on projects that included underground ducts, substructures, pads and related equipment? If yes, please upload project information sheet including project and owner name, installation dates, details of electrical scope performed and reference contact information for **at least** two projects."

#### C10 Qualification Process – Path 2

    - Section A: Contact Information
    - Section B: Contractor's License
    - Section C: Other Information about Your Firm (Ownership, license changes)
    - Section K: Bonding
    - Section L: Key Personnel
    - Section M: Recent Project Experience past 24 months
    - PROJECT #1
    - PROJECT #2
    - PROJECT #3
    - Section O: Declaration

# C10 Qualification Evaluation Criteria

- Professional licensure in good standing
- Bonding Capacity
- Verified successful completion of comparable projects
  - Zero lost time accidents
  - Client satisfaction with cut-over coordination

#### C10 Qualification Process

- Submittals must be finalized and completely uploaded no later than 5:00 pm Friday March 4, 2011.
- Uploads will not be accepted after this deadline.
- Posting of qualified C10 contractors on Friday March 11, 2011 (assuming timely reference response).
