

III. <u>CLARIFICATIONS</u>

Item No.	Reference	Description
A.	-	Fire lane shall be kept accessible at all times; Contractor may park only to load and unload.
В.	-	Scope of AC paving work to be included in Contractor's base bid is the area required to patch over the trench after it has been backfilled.
C.	-	Contractor shall be responsible for locating utilities, per Document 00 71 00 (General Conditions) Articles 2 and 11.
D.	-	Contractor shall restore to pre-construction condition all landscaping that is damaged or removed at planting areas at Building 8, per Section 01 10 00 (Summary of Work) Article 1.14.
E.	-	Top of hot water trench is approximately 1'-2' from the top of existing AC paving. Bottom of trench is approximately 5' from the top of existing AC paving.
F.	-	Conduits for exterior lighting cut across the AC path that leads down to the lower floor of Building 5. Contractor shall be careful not to damage power source to exterior campus lighting. If power to exterior campus lighting is interrupted, all power to all exterior site lighting within the path of this project is to be restored by dusk every day.
G.	-	If existing concrete aggregate pavement must be cut into during trenching, Contractor shall patch trench using AC.
Н.	-	During replacement of building domestic water isolation valves, it is anticipated that water will be shut down to the entire campus. During water shut-down, Contractor shall be responsible for Fire Watch 24 hours a day, every day until Contractor restores water service to all parts of the campus. The domestic water valve replacement is not part of the base bid.
I.	-	Contractor is advised that Building 6, Room 12, will be occupied at times during the course of construction. Pedestrians will use the northern access road to access this area.
J.	-	Perma-Pipe, Inc. has indicated that the piping can be tested in sections.
K.	-	Water, fire water, sanitary sewer, storm drain and natural gas piping are included in the specifications in case an existing utility is damaged during construction of the chilled water lines and needs to be replaced.
