# **5.2. College Budget Committee:**

#### Academic Senate Governing Council - 2009-2010

District is \$1.7 million short. No new cuts are being proposed at this time. Cañada has cut only 10% of summer sections.

There is confusion as to what the budget reductions for Cañada will be in 2010-2011. The original 10% reduction may have been reduced to about 4.3%.

The Board approved using RDA funds to restore sections. At Cañada, RDA funds will be used primarily to restore Summer sections (\$27K) and Fall/Spring sections (\$92K), with some funding also going to counseling, the library and EOPS.
