Gloria shared that, if possible, the intent is to align across the district. Ana Miladinova asked if students are placed into a transfer degree, are they able to petition into a local degree to avoid Area 7, questioning if a local degree can be taken as a transfer degree. Gloria shared that as a change in Title V, it is not the decision of the campus. As of Fall 2025, students can either use the college GE pattern or the transfer GE pattern. Ana asked if the campus had data regarding the number of local degrees versus the number of associate degrees for transfer students pursue. Maria Lara suggested this information be requested through PRIE. Frank Nguyen Le asked the meeting attendees if they were aware of what Skyline College decided at their Curriculum Committee meeting held the previous day. No one present was aware of the approval that took place. Frank asked the student representative in the room, Priyanshi, to comment on this item. Lisa Palmer asked Priyanshi her opinion regarding the presence of graduation requirements and area requirements. Priyanshi shared that from her perspective, international students are those that would face the most challenges in choosing requirements, but she does not foresee this as an issue with current students who are in the system, as long as they receive appropriate counseling.

Kat Sullivan-Torrez shared her perspective on current research noting the importance of Physical Education in students' educational journeys. She advocated that the Physical Education one unit be taken early in the student educational journey as exposure to these courses can contribute to student success for the remainder of their time at the college. Frank agreed that encouraging students to take these courses at the beginning of their journey would be beneficial, noting that working closely with counselors seems appropriate. Maria Lara agreed with this sentiment, highlighting the benefits to student mental health. Maria also proposed exposing students to library courses early on as the information they learn in these courses can enrich the remainder of their college experience. Adriana Lugo also agreed with this.

District Curriculum Committee's Recommendation for SMCCCD Local GE pattern

April 22, 2024

After gathering and analyzing feedback from constituents across the District, the District Curriculum Committee would like to recommend the creation of a GE Area 7, in our local Associates Degree pattern, to address the former Lifelong Learning/Self-Development/Career Development/Kinesiology area. The following is a draft proposal, as the finer details of exact courses and section description will continue to be finalized.

The District Curriculum Committee acknowledges that there was no "perfect" solution, but feel this recommendation provides students with some flexibility to take courses according to interests, goals, and scheduling needs. We also see this pattern benefitting student athletes, for example, who have a high number of units in PE – as they can use 3 PE units to satisfy the Area. For students who want to only take one PE class, they will have the choice of several 1-2 unit courses under 7B to meet the total 3-unit GE area requirement. The one drawback of this options is that students may end up taking 4 units to fulfill the requirement depending on the course options available for them to choose.

Please note: This general education area would replace all Kinesiology graduation requirements.

GE Area 7: Self Development and Wellness, 3 units Minimum of 1 unit from 7A

This area is designed to equip learners for lifelong understanding and development of themselves as integrated physiological, psychological, and social beings. Physical activity is required. Content may include topics such as human behavior, information literacy, mental health, nutrition, physical health, sexuality, social relationships, stress management, student success strategies, and relationships with the environment, as well as implications of death and dying or avenues for lifelong learning. Courses in this area shall focus on the development of skills, abilities, and dispositions. Courses in this area are not part of any other local GE area.

3 units of credit will be applied to Area 7 for Veterans who show proof of completing Basic Training.

Below find a preliminary list of courses that may be included in this GE area.

7A: All KINE activity courses that are not listed in other GE areas.

7B: (Districtwide courses that are offered at all campuses): BIOL 310, BUS 101, 113*, COUN courses, CRER courses, HSCI 100, Comm that doesn't count in other GE areas

David Eck highlighted that there would be 21 credits for the local GE (minimum required due to Title V) versus 34 for Cal-GETC. Adding the additional 3 units would make the local GE pattern 24 units. David stressed that college should monitor the rate of how many students are utilizing which path as this would be the closest credit difference between the two options in existence. David asked at what point would the local degree pattern become irrelevant if it becomes the rare option for students to select.

Gloria clarified that only students with catalog rights are going to be able to still use IGETC and CSU GE patterns. Students entering with catalog rights fall 2025 or after will use CalGETC for the AD-Ts. Students have the right to use the local GE pattern or CalGETC for a local degree according to the Title V regulations.

Maria highlighted that the AD-T cannot have any graduation requirements listed due to Title V. Graduation requirements can be listed for local degrees. Regardless of which GE pattern students choose for local degrees, they would still have to meet that graduation requirement.
