## • CHEM 234 Organic Chemistry I

CHEM 234 and 237 are being replaced by CHEM 231 which has both the lecture and lab components. CHEM 234/237 will be considered equivalent courses. - **Approved** 

#### • CHEM 237 Organic Chemistry Laboratory I

CHEM 234 and 237 are being replaced by CHEM 231 which has both the lecture and lab components. CHEM 234/237 will be considered equivalent courses. - **Approved** 

## 5) Addition of Courses

#### • BUS 335 Theories and Practices of Global Business

Introduction to the theories and practices of international business. Various environmental, economic, political, and social constraints on doing business abroad are explored. Topics include: political economy of international trade and investment, global monetary system, foreign market analysis and firms' operational strategy; management issues and challenges.- **Approved** 

#### • CHEM 231 Organic Chemistry

Introduction to the chemistry of hydrocarbons with emphasis on structure and reactivity of alkanes, alkenes, alkynes, alkyl halides, and conjugated systems. Mechanisms, stereochemistry and spectroscopy are an integral part of the course. Basic synthesis, separation, purification and spectroscopic techniques are introduced in the laboratory. Designed as the first semester of a one-year organic course – **Approved** 

#### • ECE 247 Foundations for School Success

Reviews criteria for curriculum and program planning to prepare children to transition from preschool into kindergarten/early elementary grades. Topics covered include: strategies for parent engagement; play-infused curriculum design to support development in all domains/subject areas; kindergarten expectations and curriculum alignment; current research, policies and issues. – **Approved**

• Small Business (AS and Certificate 18+units)

change in Program Title FROM Small Business TO Entrepreneurship and Small Business Management; b) updated and changed course offerings to be in alignment with today's needs for current and potential small business owners. Added the following courses to the core requirements section: ACTG 200, BUS. 100 and 180; deleted the following courses from the core requirements: ACTG 194, 196 (replaced by ACTG 200), BUS. 101, 108, 399 (2 units), CBOT 435 and 480. Furthermore, all of the selective requirements have been removed (COOP 670, 672 and BUS. 398). - **Approved** 

• Fashion Design: Custom Dressmaking/Small Business Oriented (AS and Certificate 18+units)

FASH 195 - Portfolio Development will increase from .5 to 1 unit and change Selectives to 4 units. Total units for degree are now 31 units. – **Approved** 

• **Fashion Merchandising** (AS and Certificate 18+units)

Updated and streamlined course offerings to be in alignment with today's needs for merchandising students. Deleted the following courses from the core requirements: FASH 113,

150 and 672. Total required units are now 18. – **Approved** 

• **Technical (Apparel Industry Oriented)** (AS and Certificate 18+units)
Updating FASH 195 from .5 to 1.0 unit and changed Electives to 7 units from 7.5 units. Total units for both the degree and certificate are now 33. – **Approved**

## • IDST 685CA Interdisciplinary Forum on Sustainability
