Regional accreditation is a well-established national process for ensuring the public's investment in quality education. Accreditation is based on the core values of academic freedom and peer review. The Accrediting Commission of Community and Junior Colleges (ACCJC) is a regional accreditor for 134 member institutions encompassing the states of California and Hawaii and the American-affiliated Pacific Islands. Accreditation is voluntary and the member institutions commit to meet continuously the agreed upon established standards set by its members. ACCJC is one of the seven regional accreditors authorized by the United States Department of Education and recognized by the Council for Higher Education Accreditation.

The ACCJC Commission consists of nineteen elected members representing faculty, administration and the public; ACCJC employs a president to carry out its policies and directives.
