NOTICE IS HEREBY GIVEN that the San Mateo County Community College District (“**District**”) of San Mateo, California, acting through its Governing Board will accept sealed bids for the award of the contract for the following public work:

DISTRICT-WIDE HAZARDOUS MATERIALS ABATEMENT UNIT PRICE CONTRACT PROJECT

Each bid must conform to and be responsive to the contract documents and be submitted on a form furnished by the District. Bids can only be submitted by those contractors with A or B licenses with Asbestos and Hazmat certification ASB/HAZ who have been pre-qualified with the District, as reflected on the District’s website: <http://www.smccd.edu/accounts/smccd/departments/facilities/PrequalCC.shtml>

DESCRIPTION OF THE WORK. The Work generally consists of **HAZARDOUS MATERIALS ABATEMENT** located at **each of the District’s Colleges:** College of San Mateo, Cañada College and Skyline College. The project includes unit price bids that will be used for future work over a total five-year term. Bidding documents contain the full description of the Work.

PREVAILING WAGE: The successful bidder shall be required to pay its workers on this project a sum not less than the general prevailing wage rate of per diem wages and not less than the general prevailing rate for holiday and overtime work for work of a similar character in the locality in which the project is performed as provided under California Labor Code section 1770 et sec. The District has determined the prevailing rate of per diem wages and the general prevailing rate for holidays and overtime work in the locality in which this project is to be performed for each craft, classification or type of work needed to execute the work.
