

NOTICE TO C10 LICENSED ELECTRICAL CONTRACTORS

NOTICE IS HEREBY GIVEN that the San Mateo County Community College District, acting through its Governing Board, is seeking to prequalify California State licensed C10 contractors who wish to compete for the electrical subcontract for the following public work: Bid #86602 North Gateway Project Phase I, Load Center #8 at the College of San Mateo.

DESCRIPTION OF THE WORK.

Bid #86602: CSM North Gateway Phase I, Load Center 8 Electrical scope includes: decommissioning of existing Load Center 4; decommissioning and demolition of existing transformer at Building 18; new underground duct banks routing electrical lines from underground sidewall of Load Center 4 and of Building 18 transformer to new Load Center 8. Installation of new Load Center 8 transformer, switchgear, lighting transformer, and lighting controls. Construction of Load Center 8 concrete pad and housekeeping pads, concrete walls, gate, and overhead grate "roof," and construction of hillside retaining site wall. Tree removal, pruning and trimming by a certified arboriculturist.

Public Works Bids for the North Gateway Project Phase I are scheduled to be accepted August 19, 2010.

PREQUALIFICATION SUBMITTALS: In order for bids to be deemed responsive, all listed C10 Electrical Contractors must have been deemed qualified to bid these projects via this qualification process, which is initiated via submittal of an online application. Contractors must request access to the application by sending an email with "C10 Contractor Prequalification" in the subject line, to the District's Construction Planning Department at plan@smccd.edu.

Qualification to bid the project will be based upon successful completion of similar projects within the past twenty-four months. The District reserves the right to determine whether or not a firm meets the requirements for qualification based upon any and all available information at the time of scoring, including but not limited to references or other information relevant to completed work on projects whether or not those projects were included in the firms qualification submittal.

APPLICATION DUE DATE: Applications must be submitted on or before 5 pm Wednesday July 21, 2010.

TWO MANDATORY QUALIFICATION CONFERENCES WILL BE HELD at 2:00 pm on Tuesday June 29, 2010 at 1700 West Hillsdale Blvd., Building 36 (Science Building) room 109, San Mateo, CA 94402, , and at 2 pm on Thursday July 8, 2010 at 1700 West Hillsdale Blvd., Building 36 (Science Building) room 109, San Mateo, CA 94402. . Prospective contractors, subcontractors and vendors are encouraged to attend. Interested parties are advised to arrive early in order to park and obtain a parking pass from a parking permit machine. Doors will be locked 15 minutes after the start time of each conference. Those who arrive after that time will be turned away.

Attendance at one of these two qualification conferences is mandatory for C10 Electrical contractors that desire to submit bids for the electrical scope of the above-referenced project.
