EXCEPTIONS

Alarm Monitoring Services

Architect (design services under GC 4525)

Architect - Landscape (design services under GC 4525)

California Conservation Corp. Labor

Donated work (no public \$\$, on public property)

If not a single public dollar is spent. Including employee salary expenses to oversee the project.

Engineering (design services under GC 4525)

Environmental Consultant

Equipment repair (copiers, vehicles, etc.)

Hydrologist services (well location)

Except when part of a well drilling project.

Janitorial services

Installation of equipment (projectors, bulletin boards, etc.) where the equipment is the majority of the cost. (aka Plug & Play or Quick Connect)

If you contract separately for the installation and the labor is less than \$1,000, exempt.

Pest control (monthly maintenance not related to a public works project)

Pest control (structural)

Except in relation to a public project such as roofing.

Public utilities (self-performing the work)

Septic tank pumping

Pool cleaning (custodial / janitorial services)

Pressure Washers (Custodial / janitorial services)

Testing

Revised Determination: inspection, sampling and testing are not public works.

NOTE: Abatement work is public works. License & DIR rules would apply.
